### Gray Gaulding #20 Krispy Kreme Toyota Camry Drive for COPD 125 Post-Race Recap

Gaulding brings home 6th place finish in NASCAR K&N Pro East Season Opener at Thunder Valley Mooresville, NC (March 18, 2013) Gray Gaulding and the #20 Krispy Kreme TruMoo Milk Toyota Camry team finished 6th in the NASCAR K&N Pro East series season opener at Bristol Motor Speedway in the Drive for COPD 125.



Gaulding and the Krispy Kreme Racing team started the weekend off on a good note 9th fastest after turning 47 laps in Thursday's opening 75 minute practice session with a fast time of 16.297, 117.7 mph.

After a quick 30 minute break final practice began. It was another 75 minute session which ended with Gaulding 2nd on the speed chart with a 16.080, 119.3 mph, 0.094 off fastest time.

The Krispy Kreme Toyota Camry was the 24th car to take time for qualifying. Gaulding ran a 16.111 putting him 13th overall. "Car just got to tight and we hit the right-front on the track" said Gaulding, "we will get it tuned up come race time."

The 125 laps Drive for COPD 125 was scheduled to start at 4:45 directly following the NASCAR

Nationwide Series event. When the green flag dropped on the Drive for COPD 125, Gaulding set his eyes on moving forward. He quickly taking over the 12th position before the first caution flag flew on lap 6. When the race went back green on lap 13, Gaulding worked his way up into the top-10, settling into 8th before the second caution flag flew on lap 30.

Gaulding reported his Krispy Kreme TruMoo Milk Toyota Camry to be a tick free, CC Doug George worked with Gray on which tire blowers to use to help tighten him up. Gaulding moved into 7th after the green flag flew on lap 34 where he would settle through the mid-race break.

Gaulding would break into the top-5 before several late race restarts held him on the bottom. Gaulding would slide back into 7th before being able to move up, he would work his way back into 6th where he would finish in the NASCAR K&N Pro East series season opener.

“Gray drove a smart race, “said Doug George crew chief of the #20 Krispy Kreme TruMoo Milk Toyota Camry. “Coming out of Bristol with a top-10 is a great points day.”
