## Gray Gaulding #20 Krispy Kreme TruMoo Milk Toyota Camry Kevin Whitaker 150 Post-Race Recap

*Gaulding brings home top-10 finish at Greenville Pickens Speedway*

Mooresville, NC (April 8, 2013) Gray Gaulding and the #20 Krispy Kreme TruMoo Milk Toyota Racing team had one goal in mind when they entered Greenville Pickens Speedway on Saturday for the Kevin Whitaker 150, log laps, learn, and bring home a top-10 finish.



Gaulding logged 25 laps in both of Saturday's practice session clocking the 10th fastest time of a 21.549 at 83.531mph in the opening session, and 11th fastest in the final session with a 21.564 at 83.472mph.

Gaulding would be the 3rd of 26 cars to take time for the Kevin Whitaker 150 and with a time of 20.841 at 86.368mph he would qualify 4th. "We thought going out early would hurt us a little, but Doug (Doug George crew chief of the #20 Krispy Kreme TruMoo Milk Toyota Camry) made the right call and it showed" said Gaulding.

When the green flag dropped for the Kevin Whitaker 150, Gaulding showed great talent moving down into 3rd and into 2nd on lap 6. Gaulding rode in second staying less than a car length of the leader and mocked every move he made.

An early caution on lap 21 set Gaulding starting on the outside of row 1 for the restart.

Gaulding would slide back and settle into 3rd, when the second caution flag flew on lap 57, Gaulding reported his Krispy Kreme TruMoo Milk Toyota to be on the tight side. Crew Chief Doug George went through adjustments Gaulding could make.

The third and final caution flag of the evening flew on lap 101. Gaulding reported his car to be getting extremely loose, again cc Doug George worked with him on backing out the adjustments. Gaulding and the #37 would get together while running 5th and 6th, they would then slide back to 9th and 10th respectfully, where they would finish.

Gaulding brought his #20 Krispy Kreme TruMoo Milk Toyota Camry home in the 10th place position. "We had a great day," said Gaulding. "We came here this weekend hoping to learn and build on moving forward. We showed a lot of speed, and I can't be more proud of this entire Krispy Kreme TruMoo Milk Toyota Racing team. We have built a great origination and have great partners supporting us."

Gaulding is currently in a three way tie for 6th in the 2013 NASCAR K&N Pro East points and leading the Sunoco Rookie of the Year points.
